

2009 BUILDING PERMIT FEES

GENERAL INFORMATION

Flat Rate Fees found in this schedule cover most new construction and major renovations. Flat Rate Flat Rate Fee schedule **DOES NOT COVER** miscellaneous other fees that may be applicable such as Plan Review, Fire Prevention Systems, DCED, Zoning, Demolition, Septic/Sewer, On Lot Storm Water Detention Sump systems, Planning & Land Development, Bonding, Escrow, Driveway, designs for structures in Flood Prone areas, Variances, Conditional Use, permits & designs for structures/equipment not typically encountered during construction, etc.

Itemized Fees found in this schedule cover specific items, repairs and situations. Itemized Fee schedules **DO NOT COVER** miscellaneous other fees that may be applicable such as, DCED, Zoning, Demolition, Septic/Sewer, On Lot Storm Water Detention Sump systems, Planning & Land Development, Bonding, Escrow, Driveway, designs for structures in Flood Prone areas, Variances, Conditional Use, permits & designs for structures/equipment not typically encountered during construction, etc.

The township appointed Code Official has final say as to how fees are to be calculated.

FLAT RATE FEES

Flat Rate Fees are based on gross aggregate which is the sum of the square footage of each floor including basement, garage, closet & storage areas over 60" in height, deck, porch, etc. up to 50,000 sq. ft. All area over 50,000 sq. ft. shall be calculated at 2 fee.

Annual and Periodical permit fees shall be determined by the Building Code Official on an individual basis.

Fee for Communication tower and associated equipment is \$450 per tower.

Fee for Windmill and associated equipment is \$250 per windmill.

Fee for Solar Photovoltaic Panels and associated equipment is \$65 + \$.25 per sq. ft. of panel surface.

Fee for Repair/Replacement of Roof Covering \$65 + \$.05 per sq. ft.

Fee for Construction and/or Storage trailer is \$65 + applicable itemized electrical fees.

Applicable permits will be required for all repairs, alterations, and additions required to bring the structure and/or property into compliance.

In the event a township employee must appear in legal proceedings relevant to the inspection, a charge for such appearance is \$90 per hour with a three hour minimum charge. An agreement must be signed by the applicant stating they are aware of and are responsible for payment of this charge.
